#### What We Know (Troubling Facts)

- One in 5 youth have a Mental Health "condition".
- Only 30% of those receive treatment.
- For treatment, school is "defacto" provider.
- On average, there is a ten year gap between on set of symptoms and treatment.
- Juvenile Justice System and Department of Corrections is next level of system default for "treatment".
- Suicide is 4th leading cause of death among young adults.
- Indiana is 2nd in the nation in the number of suicides attempted by teens and young adults.
- Factors that impact mental health are present both in and outside of school. (What are some of these factors?)

#### Each Day In America-2014

- 4 children are killed by abuse or neglect.
- 5 children or teens commit suicide.
- 24 children or teens die from accidents.
- 187 children are arrested for violent crimes.
- 408 children are arrested for drug crimes.
- 838 public school students are corporally punished.\*
- 865 babies are born at low birth weight.
- 1,392 babies are born into extreme poverty.
- 1,837 children are confirmed as abused or neglected.
- 2,723 babies are born into poverty.
- 2,857 high school students drop out.\*
- 4,028 children are arrested.

16,244 public school students are suspended.\*
\*Based on 180 school days a year.

#### **Trauma and Indiana Youth**

- 11.1% of children have had incarcerated parent.
- In 2013 15,777 homeless youth.
- In 2012 4,868 children received services based on presence of domestic violence.

(Kids Count, 2015, Indiana Coalition Against Domestic violence, 2013)

#### From the American Bar Association:

- Since the 1970's, school suspension and expulsion rates in the US have more than doubled to more than 3 million suspensions and over 9,700 expulsions.
- "Zero-tolerance" policies have fueled the increase as well as the use of law enforcement tactics by school administrators.

# Students who do not graduate from high school....

- Are 3.5 time more likely to be arrested as adults.
- Are much more likely to be and remain unemployed.
- Earn less money if they do gain employment.
- More likely to receive public assistance.
- And...83% of the adults in prison are high school dropouts.

#### Components of a Trauma Informed Schools

- When students feel safe then they will act safe. How do we support that?
  - Ask ourselves –Is the student fearful, anxious frustrated and/or tense?
  - Teachers have predictable responses to students
  - Agreed upon safe haven (area of school)
  - <u>Model and teach the behavior you want to see</u> (remember Mirror Neurons).

#### Components of a Trauma Informed Schools

- Both the young person and the adult need to be in the "right frame of mind" to problem solve in a positive manner. Both need to be in their prefrontal cortex.
- "Without...soothing by reliable and consistent caregivers, the troubled youth is unable to regulate his or her mental state and restore emotional equilibrium" Mollon in Schore, 2003

- Characteristics of the Caregiver/Support System
  - Ability to provide physical and emotional safety
  - Empathetic and attuned to individual's response
  - Contextual issues
  - Level of Social Support

#### If we build collaborative partnerships, then...

- Synergies are unleashed and the likelihood of achieving depth and quality in programs at all three tiers is greatly enhanced.
- Teams including educators and mental health providers and other community partners decide interventions.
- Multiple Interventions available based on School and Community Data.
- Collaborative System takes inventory of current practices in regards to effectiveness and fidelity before investing in new interventions or programs.
